**SECOND AMENDMENT
TO
STATEWIDE CONTRACT NO. 01520
FRESH BAKERY ITEMS**

This Second Amendment (“Amendment”) to Contract No. 01520 is made and entered into by and between the State of Washington acting by and through the Department of Enterprise Services, a Washington State governmental agency (“State”) and United States Bakery dba: Franz Family Bakeries, an Oregon company (“Contractor”) and is dated as of April 1, 2023.

R E C I T A L S

- A. State and Contractor (collectively the “Parties”) entered into that certain Contract No. 01520 for Fresh Bakery Items dated effective as of April 1, 2021 (“Contract”).
- B. The Parties previously amended the Contract 01520.
 - a. By instrument titled First Amendment (dated June 1, 2022) included the following actions:
 - i. Economic adjustment of 10.24% effective June 1, 2022, and
 - ii. Replaced Section 3.3 Economic Adjustment language, effective June 1, 2022.
- C. The amendment set forth herein is within the scope of the Contract.
- D. The Parties now desire to amend the Contract as set forth herein.

A G R E E M E N T

NOW THEREFORE, in consideration of the mutual covenants and agreements set forth herein, the Parties hereby agree to amend the Contract, as previously amended, as follows:

1. **TERM.** Contract term is extended an additional twenty-four (24) months ending March 31, 2025.
2. **ECONOMIC ADJUSTMENT.** Unites States Bakery dba: Franz Family Bakery is granted a price increase of 13.3% effective April 1, 2023. Exhibit B Prices for Goods/Services is replaced in its entirety with the attached.

3. NO CHANGE OTHER THAN AMENDMENT. Except as amended herein, the Contract is unaffected and remains in full force and effect.
4. INTEGRATED AGREEMENT; MODIFICATION. This Amendment constitutes the entire agreement and understanding of the Parties with respect to the subject matter and supersedes all prior negotiations and representations. In the event of any conflict between this Amendment and the Contract or any earlier amendment, this Amendment shall control and govern. This Amendment may not be modified except in writing signed by the Parties.
5. AUTHORITY. Each party to this Amendment, and each individual signing on behalf of each party, hereby represents and warrants to the other that it has full power and authority to enter into this Amendment and that its execution, delivery, and performance of this Amendment has been fully authorized and approved, and that no further approvals or consents are required to bind such party.
6. ELECTRONIC SIGNATURES. An electronic signature or electronic record of this Amendment or any other ancillary agreement shall be deemed to have the same legal effect as delivery of an original executed copy of this Amendment or such other ancillary agreement for all purposes.
7. COUNTERPARTS. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original, and all of which counterparts together shall constitute the same instrument which may be sufficiently evidenced by one counterpart. Execution of this Amendment at different times and places by the parties shall not affect the validity thereof so long as all the parties hereto execute a counterpart of this Amendment.

This First Amendment (“Amendment”) to Contract No.01520 is made and entered into by and between the State of Washington acting by and through the Department of Enterprise Services, a Washington State governmental agency (“State”) and United States Bakery dba Franz Family Bakeries, an Oregon company (“Contractor”) and is dated as of April 1, 2021.

RECITALS

- A. State and Contractor (collectively the “Parties”) entered into that certain Contract No. 01520 for Fresh Bakery Items dated effective as of April 1, 2021 (“Contract”).
- B. The amendment set forth herein is within the scope of the Contract.
- C. The Parties now desire to amend the Contract as set forth herein.

AGREEMENT

NOW THEREFORE, in consideration of the mutual covenants and agreements set forth herein, the Parties hereby agree to amend the Contract, as previously amended, as follows:

1. ECONOMIC ADJUSTMENT. The following two (2) actions are included in Amendment One (1).
 - a. Unites States Bakery dba: Franz Family Bakery is granted a price increase of 10.24% effective June 1, 2022. Exhibit B Prices for Goods/Services is replaced in its entirety with the attached.
 - b. Section 3.3 Economic Adjustment language is replaced in its entirety with the following.

The Contract Prices set forth herein are firm and fixed for one year from the effective date of this Master Contract. Beginning twelve (12) months after the effective date of this Master Contract and for every annual anniversary thereafter, Contractor may request an annual price adjustment. Requests for price adjustments must be made in writing and be received at least thirty (30) days prior to the adjustment date (the annual anniversary of the effective date of the Master Contract). In the event Contractor fails to timely request a price adjustment, Enterprise Services, at its sole discretion, may allow an untimely adjustment; Provided, however, that such adjustment will not be effective for any time prior to Enterprise Services’ price adjustment. Price adjustments

will be made in accordance with the percentage change in the United States Department of Labor, Bureau of Labor and Statistics (BLS) Produce Price Index (PPI), WPU021102, issued for each contract term. Only final PPI data will be used to adjust contract pricing. This Master Contract will use seasonally unadjusted indexes. If an index becomes unavailable, Enterprise Services shall substitute a proxy index. If there is not a direct substitute, the next higher aggregate index available will be used.

$$\text{New Price} = \text{Old Price} \times (\text{Current Period Index} / \text{Base Period Index})$$

The "Current Period Index" is the most recent twelve months of non-preliminary BLS Index values, and the "Base Period Index" is the average of the twelve months of non-preliminary BLS Index values prior to the Current Period Index.
