Fluorescent Orange roll up sign sheeting shall be any of the following: ORALITE® Super Bright™ or Marathon™, or 3M™ Diamond Grade™, or Avery Dennison OmniBrite™. Fluorescent Pink sign sheeting shall be ORALITE® Super Bright™

This Fifth Amendment (“Amendment”) to Contract No. 02717 is made and entered into by and between the State of Washington acting by and through the Department of Enterprise Services, a Washington State governmental agency (“State”) and Pacific Safety Supply dba Dicke Safety Products, an Oregon Corporation (“Contractor”) and is dated as of April 21, 2023.

RECITALS

- A. State and Contractor (collectively the “Parties”) entered into that certain Contract No. 02717 for Portable Roadway Signs and Stands dated effective as of October 1, 2017 (“Contract”).
- B. The Parties previously amended the Contract four times:
 - a. Amendment 1 dated October 1, 2020 (contract extension)
 - b. Amendment 2 dated March 31, 2021 (contract language revision)
 - c. Amendment 3 dated June 12, 2021 (price adjustment)
 - d. Amendment 4 dated July 12, 2022 (price adjustment)
- C. The amendment set forth herein is within the scope of the Contract.
- D. The Parties now desire to amend the Contract as set forth herein.

AGREEMENT

NOW THEREFORE, in consideration of the mutual covenants and agreements set forth herein, the Parties hereby agree to amend the Contract, as previously amended, as follows:

- 1. **TERM.** The contract term is amended to extend the term six (6) months, ending September 30, 2023.
- 2. **PRICE ADJUSTMENT.** The Contract pricing for the goods/services is hereby amended by deleting the existing *Exhibit B – Prices* in its entirety and inserting ***Exhibit A – Prices for Goods*** (dated April 21, 2023) of this amendment. As of the effective date of this Amendment, any reference to ***Exhibit B – Prices for Goods*** in the Contract shall be deemed to be a reference to ***Exhibit A – Prices for Goods*** (dated April 21, 2023) of this amendment instead.
- 3. **VENDOR MANAGEMENT FEE.** The following provision is added to Section 8.2 of the Contract, replacing the previous Section 8.2 in its entirety:

VENDOR MANAGEMENT FEE. Contractor shall pay to Enterprise Services a vendor management fee (“VMF”) of 1.25 percent on the purchase price for all Contract sales (the purchase price is the total invoice price less applicable sales tax).

- (a) The sum owed by Contractor to Enterprise Services as a result of the VMF is calculated as follows:

Amount owed to Enterprise Services = Total
Contract sales invoiced (not including sales tax) x
.0125.


- (b) The VMF must be rolled into Contractor's current pricing. The VMF must not be shown as a separate line item on any invoice unless specifically requested and approved by Enterprise Services.
 - (c) Enterprise Services will invoice Contractor quarterly based on Contract sales reported by Contractor. Contractors are not to remit payment until they receive an invoice from Enterprise Services. Contractor's VMF payment to Enterprise Services must reference this Contract number, work request number (if applicable), the year and quarter for which the VMF is being remitted, and the Contractor's name as set forth in this Contract, if not already included on the face of the check.
 - (d) Failure to accurately report total net sales, to submit a timely usage report, or remit timely payment of the VMF, may be cause for Contract suspension or termination or the exercise of other remedies provided by law. Without limiting any other available remedies, the Parties agree that Contractor's failure to remit to Enterprise Services timely payment of the VMF shall obligate Contractor to pay to Enterprise Services, to offset the administrative and transaction costs incurred by the State to identify, process, and collect such sums, the sum of \$200.00 or twenty-five percent (25%) of the outstanding amount, whichever is greater, or the maximum allowed by law, if less.
 - (e) Enterprise Services reserves the right, upon thirty (30) days advance written notice, to increase, reduce, or eliminate the VMF for subsequent purchases, and reserves the right to renegotiate Contract pricing with Contractor when any subsequent adjustment of the VMF might justify a change in pricing.
4. NO CHANGE OTHER THAN AMENDMENT. Except as amended herein, the Contract is unaffected and remains in full force and effect.
5. INTEGRATED AGREEMENT; MODIFICATION. This Amendment constitutes the entire agreement and understanding of the Parties with respect to the subject matter and supersedes all prior negotiations and representations. In the event of any conflict between this Amendment and the Contract or any earlier amendment, this Amendment shall control and govern. This Amendment may not be modified except in writing signed by the Parties.
6. AUTHORITY. Each party to this Amendment, and each individual signing on behalf of each party, hereby represents and warrants to the other that it has full power and authority to enter into this Amendment and that its execution, delivery, and performance of this Amendment has been fully authorized and approved, and that no further approvals or consents are required to bind such party.

7. ELECTRONIC SIGNATURES. An electronic signature or electronic record of this Amendment or any other ancillary agreement shall be deemed to have the same legal effect as delivery of an original executed copy of this Amendment or such other ancillary agreement for all purposes.
8. COUNTERPARTS. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original, and all of which counterparts together shall constitute the same instrument which may be sufficiently evidenced by one counterpart. Execution of this Amendment at different times and places by the parties shall not affect the validity thereof so long as all the parties hereto execute a counterpart of this Amendment.
