FIRST AMENDMENT TO STATEWIDE CONTRACT No. 03418 AUDIO-VISUAL SOLUTIONS

This First Amendment ("Amendment") to Contract No. 03418 is made and entered into by and between the State of Washington acting by and through the Department of Enterprise Services, a Washington State governmental agency ("State") and Avidex Industries, a Washington limited liability company ("Contractor") and is dated as of September 6, 2022.

RECITALS

- A. State and Contractor (collectively the "Parties") entered into that certain Contract No.03418 for Audio-Visual Solutions dated effective as of April 1, 2019 ("Contract").
- B. The amendment set forth herein is within the scope of the Contract.
- C. The Parties now desire to amend the Contract as set forth herein.

AGREEMENT

Now Therefore, in consideration of the mutual covenants and agreements set forth herein, the Parties hereby agree to amend the Contract, as previously amended, as follows:

- 1. ECONOMIC ADJUSTMENT. As directed in Section 3.3 of Statewide Contract 03418, an economic adjustment of a 16.05% increase is applied to Exhibit B labor rates not covered under Washington State Department of Labor & Industries prevailing wage as defined under Section 6 of the Contract. All catalogue discounts (% discount off list) and catalogue pricing stay the same.
- 2. NEW DATE FOR ECONOMIC ADJUSTMENTS. Section 3.3 of Statewide Contract 03418 is amended to commence economic adjustments beginning on October 31, 2023 and recurring annually thereafter until the termination of the contract, in order to better align with the publication of the OES survey.
- 3. NO CHANGE OTHER THAN AMENDMENT. Except as amended herein, the Contract is unaffected and remains in full force and effect.

- 4. INTEGRATED AGREEMENT; MODIFICATION. This Amendment constitutes the entire agreement and understanding of the Parties with respect to the subject matter and supersedes all prior negotiations and representations. In the event of any conflict between this Amendment and the Contract or any earlier amendment, this Amendment shall control and govern. This Amendment may not be modified except in writing signed by the Parties.
- 5. AUTHORITY. Each party to this Amendment, and each individual signing on behalf of each party, hereby represents and warrants to the other that it has full power and authority to enter into this Amendment and that its execution, delivery, and performance of this Amendment has been fully authorized and approved, and that no further approvals or consents are required to bind such party.
- 6. ELECTRONIC SIGNATURES. An electronic signature or electronic record of this Amendment or any other ancillary agreement shall be deemed to have the same legal effect as delivery of an original executed copy of this Amendment or such other ancillary agreement for all purposes.
- 7. COUNTERPARTS. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original, and all of which counterparts together shall constitute the same instrument which may be sufficiently evidenced by one counterpart. Execution of this Amendment at different times and places by the parties shall not affect the validity thereof so long as all the parties hereto execute a counterpart of this Amendment.
