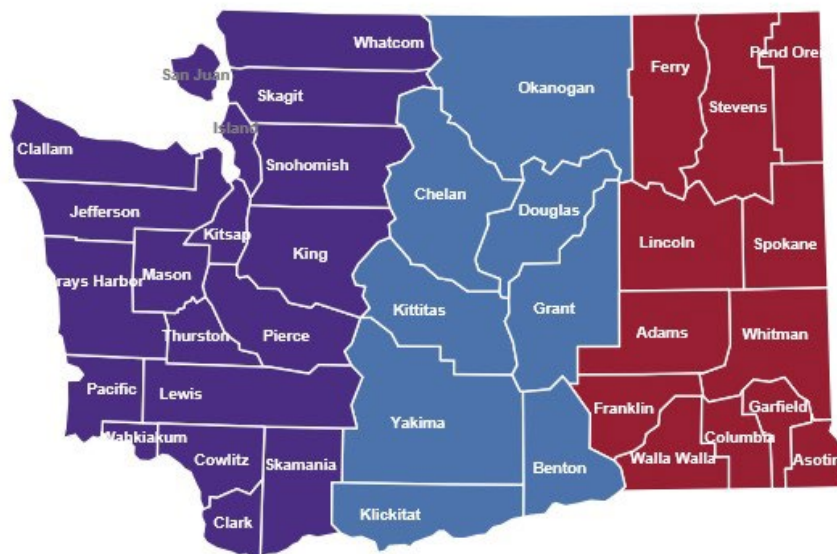

Column 1: These prevailing wage rates are for example purposes and apply only to the job classes listed in the tables for certain counties in the region for the current L&I prevailing wage rate table. NOTE: Prevailing wage tables are updated twice-yearly by Labor and Industries. Please check the Labor and Industries website at <https://secure.lni.wa.gov/wagelookup> for current wage rates.

Column 2: The contractual maximum markup percentage Contractor will apply to the then-current base prevailing wage as reflected in the official Labor and Industries wage rate tables.

Column 3: An example of the Contractor's maximum hourly wage rate based on the contractual mark-up percentage; this rate will vary depending on the county in which contract services are performed.
