Document Reviewer (Reviewers)	Attorney licensed reviewers that perform relevancy, privilege, statutory withholding, issue coding, and redaction reviews.	\$65	per Hour
Computer Forensics Technician	Forensic collections (mobile phones/devices, hard drive, servers, drones), forensic extractions and forensic analysis (internet browser and deletion activity, geolocating reports, and other computer forensic analyses.	\$250	per Hour

For example, hard copy collections on the lower end (\$125 per hour) and forensic collections on the higher end (\$250 per hour).	\$125 - \$250	per Hour
Remote Data Collection	Cloud-based email collections, social media site collections, etc. Range in hourly rates due to the type of remote collections. Email exports that can be operationalized for the lower end (\$185 per hour) to social media or website forensic collections on the higher end (\$250 per hour).	\$185 - \$250	per Hour
Export Native Files from Collected Media	Extraction of files based on file type, search terms, date filters, etc.	\$250	per Hour
