**FIRST AMENDMENT
TO
CONTRACT No. 11421
CUTTING EDGES FOR SNOWPLOWS AND GRADERS**

This First Amendment (“Amendment”) to Contract No. 11421 is made and entered into by and between the State of Washington acting by and through the Department of Enterprise Services, a Washington State governmental agency (“Enterprise Services”) and Kueper North America, LLC, a South Carolina Limited Liability Company (“Contractor”) and is dated and effective as of January 10, 2024.

R E C I T A L S

- A. Enterprise Services and Contractor (collectively the “Parties”) entered into that certain Contract No. 11421, for -Categories 1 Cutting Edges for Truck Mounted Snowplows: Subcategory C Cutting Edges with Carbide Insert, 4 Ceramic Combination Blades, and 5 Carbine Combination Blades dated effective as of 11/1/2022 (“Contract”).
- B. The Parties now desire to amend the Contract to perform an automatic annual economic price adjustment.
- C. The amendment set forth herein is within the scope of the Contract.

A G R E E M E N T

NOW THEREFORE, in consideration of the mutual covenants and agreements set forth herein, the Parties hereby agree to amend the Contract, as previously amended, as follows:

1. AUTOMATIC ECONOMIC PRICE ADJUSTMENT. Pursuant to Section 3.4 of the Statewide Contract Economic Price Adjustment using the Bureau of Labor Statistics Index combination of the following indices for each category awarded to determine price changes
 - a. *Steel: PPI Industry Data Code 3312, “Steel Product Manufacturing from Purchased Steel”, Database Series ID: PCU33123312,*
 - b. *Rubber: PPI Industry Data Code 32521, “Resin and Synthetic Rubber Manufacturing”, Database Series ID: PCU32521-32521,*
 - c. *Ceramics: PPI Industry Data Code 3271, “Clay Product and Refractory Manufacturing”, Database Series ID: PCU3271-3271,*

- d. *Transportation: PPI Industry Data Code 484 "Truck Transportation", Database Series ID: PCU585-484, and*
- e. *Labor: Employment Cost Index: Total Compensation for Private Industry Workers, "Goods Producing Industries", Database Code CIU201G000000000I, the prices set forth in the Exhibit B (attached) – are adjusted as follows for each awarded category:*



SECOND AMENDMENT
TO
CONTRACT NO. 11421
CUTTING EDGES FOR SNOWPLOWS AND GRADERS

This Second Amendment (“Amendment”) to Contract No. 11421 is made and entered into by and between the State of Washington acting by and through the Department of Enterprise Services, a Washington State governmental agency (“Enterprise Services”) and (“Contractor”) and Kueper North America, LLC, a South Carolina Limited Liability company is dated as of October 10, 2024.

RECITALS

- A. Enterprise Services and Contractor (collectively the “Parties”) entered into that certain Contract No. 11421, for -Categories 1 Cutting Edges for Truck Mounted Snowplows: Subcategory C Cutting Edges with Carbide Insert, 4 Ceramic Combination Blades, and 5 Carbine Combination Blades dated effective as of 11/1/2022 (“Contract”).
- B. The Parties previously amended the Contract as follows:
 - (1) By instrument titled First Amendment to Contract (dated January 10, 2024) to perform an automatic annual economic price adjustment.
- C. The Parties now desire to amend the Contract to include a ‘pay equality provision’ as required by the Washington State Legislature. See [LAWS OF 2023, ch. 475](#), § 919(4).
- D. The Parties further desire to amend the Contract to include a ‘nondiscrimination provision’ as required by the Washington State Legislature. See [LAWS OF 2023, ch. 468](#) [codified at [RCW 39.26.245\(3\)](#) and [RCW 49.60.530](#)].
- E. The amendment set forth herein is within the scope of the Contract.

AGREEMENT

NOW THEREFORE, in consideration of the mutual covenants and agreements set forth herein, the Parties hereby agree to amend the Contract, as previously amended, as follows:

- 1. **PAY EQUALITY.** The following provision is added to the end of section 4 (Reps and Warranty) as a new subsection:
 - 4.18 WASHINGTON STATE PAY EQUALITY FOR ‘SIMILARLY EMPLOYED’ INDIVIDUALS. Contractor represents and warrants that, among Contractor’s employees, ‘similarly

employed' individuals are compensated as equals. For purposes of this provision, employees are similarly employed if the individuals work for the same employer, the performance of the job requires comparable skill, effort, and responsibility, and the jobs are performed under similar working conditions. Job titles alone are not determinative of whether employees are similarly employed. Contractor may allow differentials in compensation for Contractor's workers based in good faith on any of the following: a seniority system; a merit system; a system that measures earnings by quantity or quality of production; a bona fide job-related factor or factors; or a bona fide regional difference in compensation levels. A bona fide job-related factor or factors may include, but is not limited to, education, training, or experience that is: consistent with business necessity; not based on or derived from a gender-based differential; and accounts for the entire differential. A bona fide regional difference in compensation level must be consistent with business necessity; not based on or derived from a gender-based differential; and account for the entire differential. Notwithstanding any provision to the contrary, upon breach of warranty and Contractor's failure to provide satisfactory evidence of compliance within thirty (30) days, Enterprise Services may suspend or terminate this Contract and any Purchaser hereunder similarly may suspend or terminate its use of the Contract and/or any agreement entered into pursuant to this Contract.

2. NONDISCRIMINATION. The following provision is added to the end of section 18 (General Provisions) as a new subsection:

18.24 NONDISCRIMINATION.

- (a) Nondiscrimination Requirement. During the term of this Contract, beginning as of the effective date of this Amendment, Contractor, including any subcontractor, shall not discriminate on the bases enumerated at RCW 49.60.530(3). In addition, Contractor, including any subcontractor, shall give written notice of this nondiscrimination requirement to any labor organizations with which Contractor, or subcontractor, has a collective bargaining or other agreement.
- (b) Obligation to Cooperate. Contractor, including any subcontractor, shall cooperate and comply with any Washington state agency investigation regarding any allegation that Contractor, including any subcontractor, has engaged in discrimination prohibited by this Contract pursuant to RCW 49.60.530(3).
- (c) Default. Notwithstanding any provision to the contrary, Enterprise Services may suspend Contractor, including any subcontractor, upon notice of a failure to participate and cooperate with any state agency investigation into alleged discrimination prohibited by this Contract, pursuant to RCW 49.60.530(3). Any such suspension will remain in place until Enterprise Services receives notification that Contractor, including any subcontractor, is cooperating with the investigating state agency. In the event Contractor, or subcontractor, is

determined to have engaged in discrimination identified at RCW 49.60.530(3), Enterprise Services may terminate this Contract in whole or in part, and Contractor, subcontractor, or both, may be referred for debarment as provided in RCW 39.26.200. Contractor or subcontractor may be given a reasonable time in which to cure this noncompliance, including implementing conditions consistent with any court-ordered injunctive relief or settlement agreement.

(d) Remedies for Breach. Notwithstanding any provision to the contrary, in the event of Contract termination or suspension for engaging in discrimination, Contractor, subcontractor, or both, shall be liable for contract damages as authorized by law including, but not limited to, any cost difference between the original Contract and the replacement or cover contract and all administrative costs directly related to the replacement contract, which damages are distinct from any penalties imposed under Chapter 49.60, RCW. Enterprise Services and/or Purchasers shall have the right to deduct from any monies due to Contractor or subcontractor, or that thereafter become due, an amount for damages Contractor or subcontractor will owe Enterprise Services and/or Purchasers for default under this provision.

3. NO CHANGE OTHER THAN AMENDMENT. Except as amended herein, the Contract is unaffected and remains in full force and effect.


