FIRST AMENDMENT TO CONTRACT No. 11421

CUTTING EDGES FOR SNOWPLOWS AND GRADERS

This First Amendment ("Amendment") to Contract No. 11421 is made and entered into by and between the State of Washington acting by and through the Department of Enterprise Services, a Washington State governmental agency ("Enterprise Services") and Norstar Industries, Inc., a Washington corporation ("Contractor") and is dated and effective as of December 15, 2023.

RECITALS

- A. Enterprise Services and Contractor (collectively the "Parties") entered into that certain Contract No. 11421, for Categories 3 Rubber Cutting Edges, 4 Ceramic Combination Blades, and 5 Carbine Combination Blades dated effective as of 11/1/2022 ("Contract").
- B. The Parties now desire to amend the Contract to perform an automatic annual economic price adjustment.
- C. The amendment set forth herein is within the scope of the Contract.

AGREEMENT

Now Therefore, in consideration of the mutual covenants and agreements set forth herein, the Parties hereby agree to amend the Contract, as previously amended, as follows:

- AUTOMATIC ECONOMIC PRICE ADJUSTMENT. Pursuant to Section 3.4 of the Statewide Contract Economic Price Adjustment using the Bureau of Labor Statistics Index combination of the following indices for each category awarded to determine price changes
 - Steel: PPI Industry Data Code 3312, "Steel Product Manufacturing from Purchased Steel", Database Series ID: PCU33123312,
 - b. Rubber: PPI Industry Data Code 32521, "Resin and Synthetic Rubber Manufacturing", Database Series ID: PCU32521-32521,
 - Ceramics: PPI Industry Data Code 3271, "Clay Product and Refractory Manufacturing", Database Series ID: PCU3271-3271,
 - d. Transportation: PPI Industry Data Code 484 "Truck Transportation", Database Series ID: PCU585-484, and

e. Labor: Employment Cost Index: Total Compensation for Private Industry Workers, "Goods Producing Industries", Database Code CIU201G0000000001, the prices set forth in the Exhibit B (attached) – are adjusted as follows for each awarded category:

Each party to this Amendment, and each individual signing on behalf of each party, hereby represents and warrants to the other that it has full power and authority to enter into this Amendment and that its execution, delivery, and performance of this Amendment has been fully authorized and approved, and that no further approvals or consents are required to bind such party.

- ELECTRONIC SIGNATURES. An electronic signature of this Amendment or any other ancillary
 agreement shall be deemed to have the same legal effect as delivery of an original executed copy
 of this Amendment or such other ancillary agreement for all purposes.
- 6. COUNTERPARTS. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original, and all of which counterparts together shall constitute the same instrument which may be sufficiently evidenced by one counterpart. Execution of this Amendment at different times and places by the parties shall not affect the validity thereof so long as all the parties hereto execute a counterpart of this Amendment.
