**FIRST AMENDMENT  
TO  
CONTRACT NO. 11421  
CUTTING EDGES FOR SNOWPLOWS AND GRADERS**

This First Amendment (“Amendment”) to Contract No. 11421 is made and entered into by and between the State of Washington acting by and through the Department of Enterprise Services, a Washington State governmental agency (“Enterprise Services”) and Rebuilding and Hardfacing, Inc., a Washington corporation (“Contractor”) and is dated and effective as of December 15, 2023.

R E C I T A L S

- A. Enterprise Services and Contractor (collectively the “Parties”) entered into that certain Contract No. 11421, for Category 1 Cutting Edges for Truck Mounted Snowplows: Subcategory A Standard Snowplow Cutting Edges, Subcategory B Special Through Hardened Snowplow Cutting Edges, and Subcategory C Cutting Edges with Carbide Insert dated effective as of 11/1/2022 (“Contract”).
- B. The Parties now desire to amend the Contract to perform an automatic annual economic price adjustment.
- C. The amendment set forth herein is within the scope of the Contract.

A G R E E M E N T

NOW THEREFORE, in consideration of the mutual covenants and agreements set forth herein, the Parties hereby agree to amend the Contract, as previously amended, as follows:

- 1. AUTOMATIC ECONOMIC PRICE ADJUSTMENT. Pursuant to Section 3.4 of the Statewide Contract Economic Price Adjustment using the Bureau of Labor Statistics Index combination of the following indices for each category awarded to determine price changes
  - a. *Steel: PPI Industry Data Code 3312, “Steel Product Manufacturing from Purchased Steel”, Database Series ID: PCU33123312,*
  - b. *Rubber: PPI Industry Data Code 32521, “Resin and Synthetic Rubber Manufacturing”, Database Series ID: PCU32521-32521,*
  - c. *Ceramics: PPI Industry Data Code 3271, “Clay Product and Refractory Manufacturing”, Database Series ID: PCU3271-3271,*

- d. *Transportation: PPI Industry Data Code 484 "Truck Transportation", Database Series ID: PCU585-484, and*
- e. *Labor: Employment Cost Index: Total Compensation for Private Industry Workers, "Goods Producing Industries", Database Code CIU201G000000000I, the prices set forth in the Exhibit B (attached) – are adjusted as follows for each awarded category:*



2. NO CHANGE OTHER THAN AMENDMENT. Except as amended herein, the Contract is unaffected and remains in full force and effect.
3. INTEGRATED AGREEMENT; MODIFICATION. This Amendment constitutes the entire agreement and understanding of the Parties with respect to the subject matter and supersedes all prior negotiations and representations. In the event of any conflict between this Amendment and the Contract or any earlier amendment, this Amendment shall control and govern. This Amendment may not be modified except in writing signed by the Parties.
4. AUTHORITY. Each party to this Amendment, and each individual signing on behalf of each party, hereby represents and warrants to the other that it has full power and authority to enter into this Amendment and that its execution, delivery, and performance of this Amendment has been fully authorized and approved, and that no further approvals or consents are required to bind such party.
5. ELECTRONIC SIGNATURES. An electronic signature of this Amendment or any other ancillary agreement shall be deemed to have the same legal effect as delivery of an original executed copy of this Amendment or such other ancillary agreement for all purposes.
6. COUNTERPARTS. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original, and all of which counterparts together shall constitute the same instrument which may be sufficiently evidenced by one counterpart. Execution of this Amendment at different times and places by the parties shall not affect the validity thereof so long as all the parties hereto execute a counterpart of this Amendment.
