FIRST AMENDMENT

TO

COOPERATIVE PURCHASING AGREEMENT No. 27723 HEATING, VENTILATION, AND AIR CONDITIONING (HVAC) PARTS

This First Amendment ("Amendment") to Cooperative Purchasing Agreement No. 27723 is made and entered into by and between the State of Washington acting by and through the Department of Enterprise Services, a Washington State governmental agency ("Enterprise Services") and MIControls Inc., a Washington Corporation ("Contractor") and is dated and effective as of February 15, 2025.

RECITALS

- A. Enterprise Services and Contractor (collectively the "Parties") entered into that certain Cooperative Purchasing Agreement No. 27723 dated effective as of August 15, 2024 ("Cooperative Purchasing Agreement" or "Contract").
- B. The Parties now desire to amend the Cooperative Purchasing Agreement to include a 'pay equality provision' as required by the Washington State Legislature. See <u>LAWS OF 2023</u>, ch. 475, § 919(4).
- C. The amendment set forth herein is within the scope of the Cooperative Purchasing Agreement.

AGREEMENT

Now Therefore, in consideration of the mutual covenants and agreements set forth herein, the Parties hereby agree to amend the Cooperative Purchasing Agreement, as follows:

- 1. PAY EQUALITY. The following provision is added to the end of section 5 (QUALITY; WARRANTY; REMEDIES) as a new subsection:
 - 5.5 WASHINGTON STATE PAY EQUALITY FOR 'SIMILARLY EMPLOYED' INDIVIDUALS. Contractor represents and warrants that, among Contractor's employees, 'similarly employed' individuals are compensated as equals. For purposes of this provision, employees are similarly employed if the individuals work for the same employer, the performance of the job requires comparable skill, effort, and responsibility, and the jobs are performed under similar working conditions. Job titles alone are not
