#### FIRST AMENDMENT

TO

#### CONTRACT No. 07621

#### ADA COMPLIANT VANS, MINIVANS, & SPECIALTY VEHICLES (I.E., ADA WALK-IN STEP VANS)

This First Amendment ("Amendment") to Contract No. 07621 is made and entered into by and between the State of Washington acting by and through the Department of Enterprise Services, a Washington State governmental agency ("Enterprise Services") and Northwest Bus Sales, Inc., a Washington corporation ("Contractor") and is dated as of April 30, 2024.

#### RECITALS

- A. Enterprise Services and Contractor (collectively the "Parties") entered into that certain Statewide Contract No.07621 for ADA-compliant Vans, Minivans, and Specialty Vehicles (collectively, ADA Walk-In Step Vans) dated effective as of January 30, 2024 ("Contract").
- B. The amendment set forth herein is within the scope of the Contract.
- C. The Parties now desire to amend the Contract as set forth herein.

#### AGREEMENT

**Now Therefore**, in consideration of the mutual covenants and agreements set forth herein, the Parties hereby agree to amend the Contract, as previously amended, as follows:

- 1. EXHIBIT B- PRICES FOR GOODS/SERVICES: Pursuant to §3.3. of the Contract, Enterprise Services has added new models/product and their options to the Contract. These new models are commercially available and fall within the original scope and intent of the Contract. Attached Exhibit B Prices for Goods/Services (dated April 30, 2024) includes new products in Category 1-ADA Vans: Sub-category 7: Gas, Side Entry, and Sub-category 8: Gas, Rear Entry, and supersedes all previous version(s). As of the effective date of this Amendment, any reference to Exhibit B- Prices for Goods/Services in the Contract is deemed to be a reference to the attached Exhibit B Prices for Goods/Services (dated April 30, 2024).
- No Change Other Than Amendment. Except as amended herein, the Contract is unaffected and remains in full force and effect.

- 3. INTEGRATED AGREEMENT; MODIFICATION. This Amendment constitutes the entire agreement and understanding of the Parties with respect to the subject matter and supersedes all prior negotiations and representations. In the event of any conflict between this Amendment and the Contract or any earlier amendment, this Amendment shall control and govern. This Amendment may not be modified except in writing signed by the Parties.
- 4. AUTHORITY. Each party to this Amendment, and each individual signing on behalf of each party, hereby represents and warrants to the other that it has full power and authority to enter into this Amendment and that its execution, delivery, and performance of this Amendment has been fully authorized and approved, and that no further approvals or consents are required to bind such party.
- ELECTRONIC SIGNATURES. An electronic signature or electronic record of this Amendment or any
  other ancillary agreement shall be deemed to have the same legal effect as delivery of an
  original executed copy of this Amendment or such other ancillary agreement for all purposes.
- 6. COUNTERPARTS. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original, and all of which counterparts together shall constitute the same instrument which may be sufficiently evidenced by one counterpart. Execution of this Amendment at different times and places by the parties shall not affect the validity thereof so long as all the parties hereto execute a counterpart of this Amendment.



#### **FIFTH AMENDMENT**

TO

## CONTRACT NO. 07621 ADA-COMPLIANT VANS, MINIVANS, AND SPECIALTY VEHICLES (I.E., ADA WALK-IN STEP VANS)

This Fifth Amendment ("Amendment") to Contract No. 07621 is made and entered into by and between the State of Washington acting by and through the Department of Enterprise Services, a Washington State governmental agency ("Enterprise Services") and Northwest Bus Sales, Inc., a Washington corporation ("Contractor") and is dated as of June 10, 2025.

#### RECITALS

- A. Enterprise Services and Contractor (collectively the "Parties") entered into that certain Contract No. 07621 for ADA-compliant Vans, Minivans, and Specialty Vehicles (collectively, ADA Walk-In Step Vans) dated effective as of January 30, 2024("Contract").
- B. The Parties previously amended the Contract as follows:
  - (1) April 30, 2024, Amendment 1 to add new models and options.
  - (2) May 30, 2024, Amendment 2 to:
    - i. Add section 2.5. ADA Vans Cooperative Parties;
    - ii. Revise section 3.3. Additions And Deletions of Models and Options; and
    - iii. Add section 8.7. Delivery Fee for the State of Alaska.
  - (3) November 15, 2024, Amendment 3 to include a 'pay equality provision' as required by the Washington State Legislature. See <u>LAWS</u> OF 2023, ch. 475, § 919(4).
  - (4) March 25, 2025, Amendment 4 to amend Exhibit B Prices for Goods/Services and grant a 3.38% price increase to the new base vehicles and options.
- C. The Parties now desire to amend the Contract to include the catalytic converter marking requirement.
- D. The amendment set forth herein is within the scope of the Contract.

#### AGREEMENT

**Now Therefore**, in consideration of the mutual covenants and agreements set forth herein, the Parties hereby agree to amend the Contract, as previously amended, as follows:

- 1. CATALYTIC CONVERTER MARKING. Per RCW 46.70.350, effective April 1, the Contractor must offer to mark the catalytic converter (CC) on the vehicle purchased by the customer and record the customer's answer, whether yes or no. CC marking price as listed in the attachment of this Amendment will be added to CARS as an option. The option will require a mandatory answer. Whether yes or no, it will be recorded in the quote, which the Contractor can use to satisfy the RCW requirement to record the answer. Marking will be listed as one of the other options. If the customer chooses to mark the CC, photo proof will be required. This section of the amendment applies to all quotes generated from April 1, 2025, until the contract expiration. It is up to the dealership to contact the customers who generated quotes from April 1 until the effective date of this amendment to collect their answers. Customers with quotes generated between April 1 and the effective date of the amendment must go into CARS to purchase the option. No purchases of this option outside of the CARS system are allowed. No additional charges are allowed. The additional line on the invoice will be allowed for CC marking or as part of the purchase. Per Exhibit B – Prices for Goods/Services of the contract, pricing will be evaluated for reasonableness, and it is at the sole discretion of DES.
- 2. NO CHANGE OTHER THAN AMENDMENT. Except as amended herein, the Contract is unaffected and remains in full force and effect.
- 3. INTEGRATED AGREEMENT; MODIFICATION. This Amendment constitutes the entire agreement and understanding of the Parties with respect to the subject matter and supersedes all prior negotiations and representations. In the event of any conflict between this Amendment and the Contract or any earlier amendment, this Amendment shall control and govern. This Amendment may not be modified except in writing signed by the Parties.
- 4. AUTHORITY. Each party to this Amendment, and each individual signing on behalf of each party, hereby represents and warrants to the other that it has full power and authority to enter into this Amendment and that its execution, delivery, and performance of this Amendment has been fully authorized and approved, and that no further approvals or consents are required to bind such party.
- 5. ELECTRONIC SIGNATURES. An electronic signature or electronic record of this Amendment or any other ancillary agreement shall be deemed to have the same legal effect as delivery of an original executed copy of this Amendment or such other ancillary agreement for all purposes.
- 6. COUNTERPARTS. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original, and all of which counterparts together shall constitute the same instrument which may be sufficiently evidenced by one counterpart. Execution of this Amendment at different times and places by the parties shall not affect the validity thereof so long as all the parties hereto execute a counterpart of this Amendment.
